(See section 180.175 of the Regulations and Rules of Practice.) Retain one copy for your files. All items on the face of the form are self-explanatory unless noted below.



'SugarBon' is the result of a hand pollinated cross between two Gallatin Valley Seed Co. snap pea breeding lines. 'SugarBon' was selected as a single plant selection (H 646-1-4) in 1976, and has been maintained as a pure-line since then.

It was observed for two years and the first increase planting occurred in 1979. A winter increase also occurred in 1979-1980.

The first sales will occur after the 1981 harvest. Seed will be on the market to home gardeners the spring of 1982.

The only variant plants observed in 'SugarBon' have been an occasional albino or variegated mutant. (One or less per thousand.) 'SugarBon' has been observed each year of increase and has every appearance of being stable.

#### Data Indicative Of Novelty

'SugarBon' has a vine type similar to most pea varieties in that it has standard leaves and tendrils. It also has green wrinkled peas of similar quality to most shell pea varieties which are in the freezing and canning industry.

'SugarBon' differs from all shell pea varieties with the characteristic of having edible pods which are free of parchment in the interlining of pod walls. Strings do develop along the sutures of it's pods as they mature. This freedom from parchment places 'SugarBon' with the edible podded type of peas.

The standard edible podded peas have thin pod walls and are harvested before the peas start to develop, while the pods are still very flat and young.

'SugarBon' differs from all standard, thin fleshed, edible podded peas in that it's pod flesh is about twice as thick and develops tightly around the peas. As 'SugarBon' pods mature they become round in cross section which also makes them very distinct from all standard edible podded varieties.

The pod characteristics of thick flesh, which develops tightly around the peas, which becomes round in cross section, and is free of pod wall parchment, places 'SugarBon' with the class of edible podded peas called "Snap Peas".

'SugarBon' is most similar to the "snap pea" varieties 'Sugar Snap', 'SugarAnn', 'SugarMel', and 'SugarRae'.

'SugarBon' differs from 'Sugar Snap' in that it has a dwarf vine (60 cm.) as compared to 160 cm. It also produces edible pods about 14 days earlier and is resistant to Powdery Mildew while 'Sugar Snap' is susceptible.

'SugarBon' and 'SugarAnn' have a very similar vine height and maturity. They differ in that 'SugarBon' is resistant to Powdery Mildew and 'SugarAnn' is susceptible.

'SugarBon' differs most significantly from 'SugarMel' and 'SugarRae' by producing edible pods 14 and 18 days earlier respectively.

Key To Significant Differences Among Snap Pea Varieties

The snap pea class differs from all shell peas by having edible pods which are free of parchment. They differ from standard edible-pod peas in that the pod walls are about twice as thick and develop tightly around the peas. Also, at the edible stage, pods become round in cross section.

Botanical Description Of 'SugarBon'

'SugarBon' is an early dwarf snap pea type with edible pods similar to 'Sugar Snap'. The first bloom occurs on the 11th node. It's total vine height is about 60 cm. The pods are edible (free of parchment). The pod wall is thicker than regular peas and develops tightly around the peas (a snap pea type). The dry pea seed is green and wrinkled, similar to shell peas.

'SugarBon' is resistant to Fusarium Wilt, race 1 and Powdery Mildew.
