

'Jumbo' is the result of a hand-pollinated cross between 'No. 1340' and H 296-4-1, a romano breeding line of Galatin Valley Seed Co. 'Jumbo' was selected as a single plant selection (H 373-1-1-1) in 1977. It has been maintained as a pure-line since then. In 1979, we determined that (H 373-1-1-1) had potential as a home-garden bean variety and increase of the seed was started. If an adequate supply of seed is produced in 1982, sales to home gardeners will begin in 1983. There have been no variant plants found in 'Jumbo' to date. 'Jumbo' has been observed each year of increase and is a stable variety.

Statement Of Novelty

'Jumbo' is most similar to the variety 'Roma'. They have romano type pods which are large and flat.

'Jumbo' differs from 'Roma' in several ways. 'Jumbo's pods are about nine centimeters longer and significantly darker in color.

'Jumbo' also has a larger bush (15 centimeters taller and 8 centimeters wider).

The seed size, shape, and color are clearly different. 'Jumbo' has larger flatter seed with a reniform shape. It's primary seed coat color is buff to tan with large brown stripes while 'Roma' has round white seed.
