Origin and Breeding History of 'Headliner'

'Headliner' (H818-1-3-1) is the result of a hand pollinated cross (made in 1975) between 'H606-5-2-2-3' (a Gallatin Valley Seed Co. breeding line) and P75-124 (a breeding line from Rogers Brothers Seed Company).

'Headliner' was selected as a single plant selection (H818-1-3-1) in 1978, and has been maintained as a pureline since then. This line was observed in 1979. The first increase planting occurred in 1980. The first trial sale of 4,450 pounds of seed was made in 1982. Commercial sales will begin in 1983. A total of 116,000 pounds of seed have been ordered.

'Headliner' has been observed each year of increase and is stable. The only variant plants observed have been a trace (less than one per thousand) of albino and variegated mutants. These variants are a common problem in peas.



Novelty Statement

'Headliner' is most similar to 'Sounder' (a Rogers Brothers Seed Company variety). 'Headliner' differs from 'Sounder' in that 'Headliner' produces double pods at each node and 'Sounder' produces multi-pods.

'Headliner' is less similar to the freezer varieties 'Trident', 'Puget', 'Parlay' and 'Tripod'. 'Headliner' differs from 'Trident', 'Puget', 'Parlay' and 'Tripod' in that 'Headliner' produces double pods at each node and 'Trident', 'Puget', 'Parlay', and 'Tripod' all produce multi-pods.

'Headliner' is also less similar to the variety 'Dark Skin Perfection'. 'Headliner' differs from 'Dark Skin Perfection' in that 'Headliner' is resistant to Powdery Mildew (Erysiphe polygoni DC) and 'Dark Skin Perfection' is susceptible.

'Headliner' is a mid to late freezer pea. It blooms on the 15th to 16th nodes, and normally produces two pods per node. It grows to a height of 61 cm. It is resistant to Races 1, 5, and 6 (Fusarium Wilt), Powdery Mildew (Erisiphe polygoni DC) and Pea Leaf Roll Virus (Legume Yellows Virus). It is rather determinate, producing its pods in a compact set.
