



*'SUGAR DADDY'*

'~~Stringless Sugar Snap II~~' is the result of a hand pollinated cross between SP62-2 and H747-1, two Gallatin Valley Seed Co. "snap pea" breeding lines.

'~~Stringless Sugar Snap II~~' was selected as a single plant selection (SP110-1-2) in 1978, and has been maintained as a pure line since then. An increase planting of six pounds occurred in 1980. '~~Stringless Sugar Snap II~~' has been observed each year since it was selected and is stable and uniform. No off types have been observed.

As yet, no sales of '~~Stringless Sugar Snap II~~' have occurred.

## Data Indicative Of Novelty

~~'SUGAR DADDY' R/S 10/27/84~~  
~~'Stringless Sugar Snap II'~~ has a vine type similar to most pea varieties in that it has standard leaves and tendrils.

~~'SUGAR DADDY'~~  
~~'Stringless Sugar Snap II'~~ differs from all shell pea varieties with the characteristic of having edible pods which are free of parchment in the interlining of the pod walls. This freedom from parchment places ~~'Stringless Sugar Snap II'~~ with the edible-pod type peas. ~~'SUGAR DADDY'~~

The standard edible-pod pea has thin pod walls and is harvested before the peas start to develop, while the pods are still very flat and young.

~~'SUGAR DADDY'~~  
~~'Stringless Sugar Snap II'~~ differs from all standard thin fleshed, edible-pod peas in that it's pod flesh is about twice as thick and develops tightly around the peas. As ~~'SUGAR DADDY'~~ ~~'Stringless Sugar Snap II'~~ pods mature they become round in cross section which also makes them very distinct from all standard edible-pod varieties.

The pod characteristics of thick flesh, which develops tightly around the peas, which become round in cross section and is free of pod wall parchment, places ~~'SUGAR DADDY'~~ ~~'Stringless Sugar Snap II'~~ with the class of edible-pod peas called "snap peas".

~~'SUGAR DADDY'~~  
~~'Stringless Sugar Snap II'~~ is most similar to it's sister variety 'Stringless Sugar Snap'. They are both stringless and nearly identical in every way except vine length. ~~'SUGAR DADDY'~~ ~~'Stringless Sugar Snap II'~~ averages 18 cm. taller than 'Stringless Sugar Snap'.

~~'SUGAR DADDY'~~  
~~'Stringless Sugar Snap II'~~ has "snap pea" pods similar to 'Sugar Snap', 'Sugar Ann', 'Sugar Bon', and 'Sugar Rae'. ~~'SUGAR DADDY'~~ ~~'Stringless Sugar Snap II'~~ differs from these and all other established "snap pea" varieties in that it's pods are free of strings when grown at temperatures over 20° C. If the temperature falls below 20° C., light strings may develop.

Note 2 Genetically the seed should be wrinkled but the gene for stringless seems to affect the seed characteristic in that it becomes more dimpled or smooth. ~~'Stringless Sugar Snap II'~~ has a tendency to produce mostly smooth seed.

Additional Description Of ~~'Stringless Sugar Snap II'~~

*'SUGAR DADDY'*  
~~'Stringless Sugar Snap II'~~ is a short vined "snap pea" type which has been bred for the home garden and processing industry. The pods develop free of strings when daytime temperatures are over 20<sup>0</sup> C. Below that temperature, light strings may begin to develop.

The pods are born on very short pedestals and are concentrated at the top of the plant. The concentrated pod set at the top of the plants is designed to facilitate harvesting.

*'SUGAR DADDY'*  
~~'Stringless Sugar Snap II'~~, at this stage, appears to be the second choice as a processor "snap pea" variety but may prove to be the first choice for home gardeners. 'Stringless Sugar Snap' is considered as the first choice for processing. These sister varieties are very similar in all characteristics except *'SUGAR DADDY'*  
~~'Stringless Sugar Snap II'~~ is about 18 cm. taller. It is anticipated that in some areas the extra height may be of value.

*'SUGAR DADDY'*  
~~'Stringless Sugar Snap II'~~ has a good complex of disease resistance in that it is resistant to Fusarium Wilt Race 1, Powdery Mildew, and Top Yellows Virus.
