Exhibit A. Origin and Breeding History of the Variety

Soybean Variety 90M80

Variety 90M80 evolved from a cross made in the summer of 1999 in Minnesota with the following parentage:

Parentage = 92B12/R03199

R03199= 90A07/R02322

R02322= 90B43/12223R006

12223R006= 9007/90733

90733= P9172/90676

90676= ST2250/G40-3P9392*

* G40-3P9392 is an experimental line with the Roundup Ready® (40-3-2) gene

Variety 90M80 is an F4-derived line which was advanced to the F4 generation by modified single-seed descent. The F4 progeny row of 90M80 was grown in a plant row yield trial in Minnesota in the summer of 2001. Subsequently, 90M80 has undergone five years of extensive testing and purification and has been observed by the breeder to be uniform and stable for all plant traits from generation to generation, with no evidence of variants. On the basis of yield, soybean cyst nematode resistance (race 3), phytophthora resistance, and resistance to Roundup® branded herbicides; variety 90M80 was assigned a commercial number.

The purification block was grown in Minnesota during the summer of 2004 and 60 sub-lines were harvested. A quarter (0.25) acre increase was grown in Chile in the winter of 2004/2005. Thirteen (13) acres of parent seed stock (foundation seed equivalent) and production seed were grown in the summer of 2005, and approximately 580 acres of seed stock and production seed were grown in the summer of 2006.

Exhibit B. Statement of Distinctness

Soybean Variety 90M80

Variety 90M80 is most similar to Dekalb variety CX072. Both varieties have purple flowers, gray pubescence, yellow seed with imperfect black hila, and tan pod walls. However 90M80 has resistance to *Phytophthora megasperma* as governed by the Rps1c gene, resistance to Race 1 and 3 of the soybean cyst nematode and resistance to Roundup® branded herbicides, whereas CX072 has resistance to *Phytophthora megasperma* as governed by the Rps1k gene and no resistance to the soybean cyst nematode or Roundup® branded herbicides.



90M80 is rated as above average for aphid antibiosis. On a scale of one to nine with one being fully susceptible, and nine being completely resistant; 90M80 is rated seven.

Exhibit D. Additional Description of the Variety

Soybean Variety 90M80

In Exhibit C we have identified variety 90M80 as susceptible to bacterial blight, brown spot, pod and stem blight, rhizoctonia root rot, bud blight, yellow mosaic, cowpea mosaic, pod mottle and seed mottle.

This does not mean that variety 90M80 is any worse for these problems than other varieties of similar maturity. Rather, we do not consider 90M80 to be immune to these problems. Therefore, we have chosen to be conservative and have identified the line as "susceptible".

Variety 90M80 is a late Group 0 variety. If Group 0 varieties are divided into tenths, the relative maturity of 90M80 is 0.8.


