

Cotton Varieties Planted, United States
1994 Crop

Deltapine owned varieties were the most popular upland cotton planted in the United States for the 1994-95 season, according to the Cotton Division, Agricultural Marketing Service, USDA. Stoneville owned varieties were the second most popular followed by CPCSD, All-Tex and Hyperformer.

Deltapine owned varieties were the most popular planted in 1994, accounting for 72.6 percent of the United States acreage. These varieties lead in Arizona, Texas, Oklahoma, Alabama, North Carolina, South Carolina, Georgia, Florida, Arkansas, Mississippi, Missouri, Tennessee, and Louisiana. The most popular Deltapine variety was Paymaster HS 26 which accounted for almost 18 percent of the United States acreage planted.

Stoneville owned varieties were the second most popular planted in 1994, accounting for 8.5 percent of the United States acreage. These varieties were the second most popular planted in Arkansas, Missouri, Tennessee, Louisiana, Oklahoma, South Carolina, Georgia, and Texas. Stoneville 453 was the most popular Stoneville variety and accounted for about 3 percent of the U.S. acreage.

CPCSD (California Planting Cotton Seed Distributors) varieties were the third most popular planted in 1994. These varieties accounted for 6.6 percent of the U.S. acreage. These varieties were the most popular planted in California. The leading CPCSD variety was Acala Maxxa, accounting for 6.2 percent of the U.S. acreage planted.

All-Tex varieties were the next most popular and accounted for 1.9 percent of the acreage planted in 1994. All-Tex varieties were planted in Texas, Oklahoma, and New Mexico. All-Tex Atlas was the most popular variety and accounted for 0.9 percent of the U.S. acreage.

Hyperformer was the fifth most popular group planted in 1994, accounting for 1.8 percent of the U.S. acreage. Hyperformer was the second most popular variety planted in Alabama and North Carolina. The leading Hyperformer variety was HS 46.

Pima S-7 was the most popular American Pima variety planted in 1994. This variety accounted for 58.1 percent of the United States acreage and accounted for 75.3 percent of the American Pima acreage in California and 63.3 percent of the acreage in Arizona. Pima S-6 accounted for 83.2 percent of the American Pima acreage in Texas and 50.9 percent in New Mexico.

Estimates of the percentage of the various varieties of cotton planted in the United States for 1994 by counties, classing offices and states are presented in this report. The variety data are based primarily on estimates furnished by cotton ginners for the territories served by their gins.
